Perché l'attivista novax Jean-Bernard Fourtillan è ricoverato in psichiatria?

L'anziano farmacista Jean-Bernard Fourtillan, ex attivista no-vax. è stato incarcerato in relazione al caso di studi clinici clandestini con il professor Joyeux. Da allora è stato ricoverato nel reparto psichiatrico per motivi medici.

Spiegazioni.

Perché Jean-Bernard Fourtillan, 77 anni, è ora internato all'ospedale psichiatrico di Uzès, nel Gard? Ex farmacista in pensione e attivista anti-vaccino, è apparso di recente nel documentario Hold-Up dove ha affermato in particolare che il coronavirus era stato "prodotto dall'Istituto Pasteur"? Informazioni false verificate da AFP e smentite dall'Istituto, che ha sporto denuncia contro X per diffamazione. Queste prove, condotte nell'Abbazia di Saint-Croix vicino a Poitiers, sono state condotte su almeno 350 pazienti con Parkinson, Alzheimer o affetti da disturbi del sonno. In questo caso, i professori Fourtillan e Joyeux sono perseguiti dall'Ordine dei medici per ciarlataneria. Ed è in questo contesto che Jean-Bernard Fourtillan è stato arrestato il 7 dicembre e incarcerato presso il centro di custodia cautelare di Nîmes. Quindi, la visita medica ivi svolta si è conclusa con la necessità di cure mediche, in psichiatria, presso l'ospedale di Mas Careison, a partire dal 10 dicembre. Un "internamento abusivo", secondo i suoi sostenitori Se la giustizia garantisce che questa decisione sia giustificata da "ragioni mediche", i sostenitori di Jean-Bernard Fourtillan denunciano un internamento "contro la sua volontà", inteso a zittirlo, in particolare per le sue posizioni anti-vaccino e le sue recenti osservazioni sul coronavirus. Sui social, quindi, chiamano in "soccorso" il professore. Da allora, il centro ospedaliero di Uzès è stato molestato dal sostegno dell'ex farmacista. Interrogato dal Midi Libre, il dottor Jean-Philippe Labrèze, naturopata e vicino al professor Fourtillan, ha espresso la sua rabbia contro "questo internamento abusivo che è una chiara violazione delle libertà pubbliche". Ha fatto parte di una manifestazione sabato 12 dicembre davanti ai cancelli dell'ospedale psichiatrico. "SDRE", l'ex "ricovero obbligatorio" Ma questo internamento è effettivamente una violazione delle libertà? Il pubblico ministero di Nîmes assicura a France 3 Occitanie che Jean-Bernard Fourtillan è "informato dei suoi diritti" e "può presentare ricorso contro la decisione amministrativa dinanzi al giudice delle libertà e della detenzione". Questa procedura è infatti regolamentata per legge e corrisponde ad un protocollo di "ricovero psichiatrico su decisione del rappresentante dello Stato" (SDRE), già denominato "ricovero obbligatorio". Riguarda "le persone i cui disturbi mentali richiedono cure e compromettono la sicurezza delle persone o minano gravemente l'ordine pubblico", specifica un documento del Dipartimento Affari Legali di Assistenza Pubblica Ospedaliera di Parigi (AP-HP). Presto ricevuto in udienza Dopo un periodo di osservazione di 72 ore sotto forma di ricovero completo, i medici della persona con ERDS hanno due scelte: mantenere il paziente in ricovero completo o indirizzarlo a un programma di cura. Nel caso di Jean-Bernard Fourtillan, salvo la revoca del provvedimento di ricovero ospedaliero per motivi medici o amministrativi nei prossimi giorni, "sarà ricevuto in udienza da un giudice con l'assistenza obbligatoria di un avvocato", specifica infine il pubblico ministero di Nîmes.

Essais cliniques non autorisés

Mais un an avant l’actualité brûlante du covid, Jean-Bernard Fourtillan était déjà dans le viseur de la justice, pour avoir réalisé des [essais cliniques non autorisés avec le professeur Henri Joyeux](#) au sein du "Fonds Josefa". Ces essais réalisés dans l’Abbaye Saint-Croix près de Poitiers ont été mené sur au moins 350 malades de Parkinson, d’Alzheimer ou souffrant de troubles du sommeil.

Dans le cadre de cette affaire, les professeurs Fourtillan et Joyeux [font l’objet de poursuites](#) de l’Ordre des médecins pour charlatanisme. Et c’est dans ce contexte que Jean-Bernard Fourtillan a été arrêté le 7 décembre et placé en détention provisoire à la maison d’arrêt de Nîmes. Puis, l’examen médical qui y a été mené conclu à la nécessité d’une prise en charge médicale, [en psychiatrie](#), à l’hôpital du Mas Careison, dès le 10 décembre.

Un "internement abusif", selon ses partisans

Si la justice assure que cette décision est justifiée par des "raisons médicales", les partisans de Jean-Bernard Fourtillan dénoncent un internement "contre son gré", destiné à le faire taire, notamment pour ses [positions anti vaccins](#) et ses récents propos concernant le coronavirus. Sur les réseaux sociaux, ils appellent donc à "secourir" le professeur. Depuis, le centre hospitalier d’Uzès est harcelé par les soutiens de l’ancien pharmacien.

Interrogé par le [Midi Libre](#), le docteur Jean-Philippe Labrèze, naturopathe et proche du professeur Fourtillan, exprime sa colère contre "cet internement abusif qui est une violation manifeste des libertés publiques". Il faisait partir d’un rassemblement samedi 12 décembre devant les grilles de l’hôpital psychiatrique.

"SDRE", l’ancienne "hospitalisation d’office"

Mais cet internement est-il effectivement une violation des libertés ? Le procureur de la République de Nîmes assure auprès de [France 3 Occitanie](#) que Jean-Bernard Fourtillan est "informé de ses droits" et "peut exercer un recours contre la décision administrative devant le juge des libertés et de la détention".

Cette procédure est en effet légalement encadrée et correspond à un protocole d'"admission en soins psychiatriques sur décision du représentant de l’État" (SDRE), autrefois appelée "hospitalisation d’office". Elle concerne "les personnes dont les troubles mentaux nécessitent des soins et compromettent la sûreté des personnes ou portent atteinte, de façon grave, à l’ordre public", précise un document de la [Direction des Affaires Juridiques de l’Assistance-Publique des Hôpitaux de Paris](#) (AP-HP).

Bientôt reçu en audience

Après une période d'observation de 72 heures sous la forme d'une hospitalisation complète, les médecins de la personne en SDRE ont deux choix : maintenir le patient en hospitalisation complète, ou l'orienter vers un programme de soin.

Dans le cas de Jean-Bernard Fourtillan, sauf levée de la mesure d'hospitalisation pour raison médicale ou administrative dans les prochains jours, "il sera reçu en audience par un juge avec obligatoirement l'assistance d'un avocat", précise enfin le procureur de la République de Nîmes.

Jean-Bernard Fourtillan è uno scienziato molto apprezzato in Francia, o meglio, era molto apprezzato. Oggi non più. Cos’ha sbagliato quest’uomo per essere caduto così in basso nel gradimento dei media di stato? Beh, si oppone al virus mRNA, di cui denuncia la pericolosità, e sostiene che il Covid-19 è un prodotto di laboratorio brevettato da più soggetti, tra cui l’Istituto Pasteur. Inoltre, secondo le sue analisi, gli **11 vaccini obbligatori** per i neonati contengono 17 volte la **dose massima di alluminio** definita tossica dall’Organizzazione Mondiale della Sanità. Professore esperto rinchiuso in ospedale psichiatrico dopo aver messo in discussione la narrativa ufficiale di COVID

Jean-Bernard Fourtillan, un professore universitario francese, ora in pensione, noto per la sua forte opposizione ai vaccini COVID-19 come quelli attualmente distribuiti nel Regno Unito, è stato prelevato dalla sua casa nel sud della Francia da una squadra di “gendarmi” e rinchiuso in isolamento presso l’ospedale psichiatrico di Uzès.

L’uso sistematico degli ospedali psichiatrici per mettere a tacere o punire gli oppositori politici si è diffuso sotto il comunismo, essendo iniziato poco dopo la rivoluzione bolscevica del 1917. Secondo il codice penale dell’URSS del 1966, la repressione dei dissidenti prende di mira apertamente coloro che **“diffondono falsa propaganda diffamando lo Stato sovietico e il suo sistema sociale”**.

Fourtillan, un critico di lunga data dei vaccini che utilizzano coadiuvanti pericolosi come l’**alluminio** (gli 11 vaccini obbligatori per i neonati in Francia contengono 17 volte la dose massima di alluminio definita tossica dall’Organizzazione Mondiale della Sanità), si è espresso durante la crisi del COVID-19. Offre spiegazioni e avvertimenti “alternativi” per quanto riguarda l’apparizione del virus SARS-COV-2 e dei vaccini

mRNA che funzionano iniettando pezzi del virus RNA con nanolipidi per indurre le cellule umane a iniziare a fabbricare particelle virali e quindi a innescare una reazione immunologica.

In particolare, Fourtillan ha accusato l'Istituto Pasteur, una fondazione privata senza scopo di lucro specializzata in biologia, microrganismi, malattie contagiose e vaccinazioni, di aver “prodotto” il virus **SARS-COV-2** per diversi decenni e di aver avuto un ruolo nella “fuga” di questo virus dal laboratorio cinese di Wuhan P4, all’insaputa delle autorità cinesi.

Nel 2017, l’allora ministro degli Interni francese, **Bernard Cazeneuve**, partecipò alla cerimonia ufficiale di apertura del laboratorio P4 dell’Istituto di virologia di Wuhan, insieme a **Yves Lévy**, copresidente del comitato direttivo. Lévy è marito di **Agnès Buzyn**, che era il ministro della Salute francese quando è scoppiata la crisi del COVID-19. È stata anche responsabile della firma del decreto che ha vietato le vendite da banco di **idrossiclorochina** in Francia nel gennaio 2020.

L’accusa di Jean-Bernard Fourtillan è vera? Mentre l’Istituto Pasteur ha annunciato verbalmente che avrebbe citato in giudizio Fourtillan per l’accusa, nessuna azione giudiziaria è stata avviata sul fronte giudiziario e in effetti, lo stesso Fourtillan ha presentato una denuncia contro un portavoce dell’Istituto per diffamazione.

Fourtillan ha dichiarato che spera che i procedimenti legali gli consentano di produrre le prove che ha accumulato nel tempo: è infatti ansioso di discutere le questioni in gioco. Ora che si trova in un ospedale psichiatrico, la possibilità che ciò accada – nell’interesse di scoprire la verità – sta diventando sempre più remota.

Tra i documenti pubblici che Fourtillan ha analizzato e reso pubblico ci sono i **brevetti per SARS-COV-1**, che contiene parti del virus della malaria, risalenti al 2003. I brevetti sono stati utilizzati da vari laboratori per sviluppare vaccini. Nel 2011 l’Istituto Pasteur ha presentato un’ulteriore domanda di brevetto per “SARS-COV-2”, che era identica alla precedente, secondo Fourtillan, il quale afferma che ciò è stato fatto perché lo sfruttamento commerciale del primo brevetto è iniziato nel 2003 e scadeva 20 anni dopo, vale a dire nel 2023.

Secondo Fourtillan, **quattro sequenze del virus HIV** – responsabile dell’AIDS – sono state aggiunte al virus, in vista della creazione di ulteriori vaccini.

Questo punto è stato sollevato anche in Francia lo scorso aprile dal Prof. **Luc Montagnier**, che ha vinto il Premio Nobel 2008 per la medicina per aver scoperto l’HIV nel 1983 insieme ad un’altra scienziata francese, **Françoise Barré-Sinoussi**.

Lo scorso aprile, Montagnier ha dichiarato che il virus SARS-COV-2 era il risultato di una manipolazione umana. È stato ridicolizzato dai media mainstream, ma ad agosto un microbiologo italiano è giunto alla stessa conclusione: il prof. **Joseph Tritto** ha pubblicato un libro definendo il virus Wuhan una “chimera”.

Montagnier, che aveva lavorato con un matematico, descrisse le sue scoperte attraverso un'analogia. Immagina il coronavirus come un “puzzle” con 30.000 pezzi, quindi considera diversi altri puzzle da 9.000 pezzi che rappresentano l’HIV-1, l’HIV-2 e il SIV (un altro retrovirus vicino al virus dell’AIDS ma rivolto alle scimmie).

Se tre pezzi provenienti da ciascuno di questi puzzle più piccoli si trovassero uno accanto all’altro nel puzzle da 30.000 pezzi, la probabilità che ciò sia accaduto naturalmente sarebbe nulla. Questo è analogo alla presenza di parti della sequenza dell’HIV in SARS-COV-2, secondo Montagnier.

Secondo Fourtillan, l’attuale virus che causa COVID-19 è questo **virus artificiale**. Fourtillan – così come altri ricercatori – considera questa una prova indiscutibile che la pandemia COVID-19 è stata pianificata. Ritiene che il 13 ottobre 2015 sia stata presentata una domanda di brevetto per un test COVID-19; questa è stata seguita dalla commercializzazione in tutto il mondo nel 2017 per ben 10 miliardi di dollari.

Queste affermazioni sono contestate sulla base del fatto che il riferimento al brevetto del 2015 è solo una parte del successivo brevetto del maggio 2020, anch’esso depositato da un certo **Richard A. Rothschild**, ma è stato citato come relativo alla diagnosi remota di COVID-19, migliorando l’originale brevetto per così dire per il caso particolare di COVID-19.

Chi ha ragione? Una valutazione e un dibattito pubblico e sincero solleverebbero qualsiasi confusione o errore, volontario o meno, ma Fourtillan viene ora trattato come se fosse sia pericoloso che pazzo.

Fourtillan ha ottenuto un’ampia pubblicità quando un recente film di **Pierre Barnérias**, che dava voce ai critici della narrazione ufficiale, è diventato virale in Francia. In Hold-Up, Fourtillan ha parlato della sua preoccupazione per il fatto che la crisi del COVID-19 sia stata inventata e venga utilizzata per imporre un pericoloso vaccino alla popolazione mondiale.

Fourtillan conosce lui stesso le procedure di brevettazione, come mostra il suo curriculum, avendo depositato personalmente circa **400 brevetti in campo medico**. Il mezzo Internet francese *France Soir* lo ha descritto come segue:

“Jean-Bernard FOURTILLAN, Ph.D., Ingegnere chimico, Farmacista, Farmacista ospedaliero, Professore di Chimica Terapeutica e Farmacocinetica presso la Facoltà di Medicina e Farmacologia dell’Università di Poitiers, Esperto Farmacologo tossicologo, specializzato in farmacocinetica”.

L’internamento forzato di Fourtillan non ha fatto menzione della controversia COVID-19, che fino ad oggi non ha portato a procedimenti giudiziari, essendo invece ufficialmente collegata a una causa che è stata aperta contro di lui per pratica illegale della medicina a causa del suo lavoro su un cerotto ormonale contro malattie neuro-degenerative come il morbo di Parkinson, l’Alzheimer e altre che influenzano la motricità, l’equilibrio e la memoria, nonché i disturbi del sonno.

La sua teoria è che l'inquinamento, gli adiuvanti come l'alluminio nei vaccini e l'interferenza elettromagnetica distruggano la materia oscura nel cervello per mancanza di ormoni, e ha testato – con successo, afferma – la somministrazione di un cerotto ormonale di valentonina e 6- Méthoxy-Harmalan (ormoni del sonno e della veglia), per risolvere il danno, su 402 adulti, compreso lui stesso, che hanno accettato la procedura sotto la loro esclusiva responsabilità e che sono stati avvertiti che il cerotto non era un farmaco, ma un “campione tecnico, non per uso umano.” La procedura costa solo una frazione del prezzo dei farmaci di nuova concezione per queste condizioni.

Fourtillan aveva stabilito un buon rapporto con il giudice incaricato delle indagini preliminari sul caso, Brigitte Jolivet di Poitiers. Durante i suoi primi interrogatori alla fine del 2019, sembrava convinta dalle sue argomentazioni e il caso stava procedendo normalmente.

Il mese scorso, Fourtillan, che si trovava nel sud della Francia con la moglie, è stato visitato da quattro gendarmi che hanno chiesto i suoi computer. Sebbene non avessero un mandato di perquisizione, Fourtillan li consegnò, dicendo che non aveva nulla da nascondere e che, al contrario, era ansioso di far valutare i suoi documenti e metodi.

Giorni dopo, i suoi conti bancari e le sue **carte di credito furono improvvisamente bloccati**. Anche le sue pensioni sono state bloccate.

Fourtillan era stato convocato per un’udienza nella causa riguardante il suo “trattamento” con valentonina il 4 dicembre a Parigi. Non è andato, invocando il fatto che non aveva modo di pagare un biglietto del treno per la capitale francese.

Sei giorni dopo, giovedì mattina, i gendarmi sono tornati a casa di Fourtillan e gli hanno chiesto di accompagnarli per rispondere alle domande sul suo rifiuto di partecipare all’udienza del 4 dicembre a Parigi. Da allora non ha più potuto comunicare con la sua famiglia. Uno dei suoi avvocati, Marc Fribourg ha rivelato che è stato portato all’ospedale psichiatrico di Le Mas Careiron di Uzès, dove è tuttora detenuto.
